Short Terms:

Violating this will get your submission banned. It will only be viewable by you:

- Your submission must not violate Steam Subscriber Agreement.
- Your submission must not contain offensive content. (e.g. racism, gore)
- Your submission must not contain pornographic content.
- You must be the owner of uploaded submission.

Violating these will get your submission incompatible. It will be viewable by you and your friends:

- **Do not use unlicensed music** Try to avoid copyright infringement and always leave copyrights for music in the description
- Do not upload bad quality maps Maps with bad timing or without synchronization with music will be marked as incompatible by a moderator. More info about moderation: http://steamcommunity.com/app/513510/discussions/1/1369506834142229553/
- **Do not upload broken maps** Erroring maps will be removed.
- Do not upload malicious code All maps containing any sort of exploit or backdoor will be removed.
- **Do not reupload newer versions of your maps** Update the old one, don't upload a new one. Duplicates will be removed.
- Do not abuse tags Mistagged maps will be taken down.
- **Do not upload empty or 'test' maps** Maps with no content or barely any content are pointless and are not allowed. Make effort with the content you upload.

Full Terms:

- 1. These Terms:
 - 1. apply to all use of the map and will form a binding agreement between you and KHB-Soft ("Agreement");

- 6. In consideration of KHB-Soft letting you create the map you hereby grant KHB-Soft an exclusive (including exclusive to yourself), worldwide right and license for the full period in which copyright subsists in the map to make commercial use of your map in connection with physical products.
- 7. You hereby acknowledge and agree that the Distribution of your map via the Network is subject to these Terms and Terms and Conditions available here, which are deemed incorporated into these terms by this reference.
- 8. You agree that the end user licence agreement available ("EULA") shall apply to the map and that the map shall be Distributed to end users on and subject to the terms of that EULA.
- 9. You agree that we shall own and you shall not make any claim over those Intellectual Property Rights which KHB-Soft may own in respect to enhancements, adaptions or otherwise changes to your map.

map Submissions

Confidentiality

20.In the event that you receive confidential information of KHB-Soft you agree to keep it confidential and not disclose it or any part of it to any third party (except to your own employees and professional advisers who have a need to know - and then only on a need to know basis and on sufficient terms of confidentiality) nor use the same for any purpose inconsistent with these Terms and the Agreement.

General

- 23.Reference to the word "including" shall be read as to be "without limitation".
- 24. This Agreement is personal to you. You may not assign or transfer all or part of it.
- 25.Nothing in these Terms shall be deemed to constitute a partnership relationship between the parties and neither party shall hold itself out as a partner of the other party.
- 26.If KHB-Soft does not enforce any provision of this agreement such will not be considered a waiver of any provision or right and no waiver by either party of any breach by the other of any of the provisions of these Terms shall operate as a waiver of any preceding or succeeding breach of the same or any other provision of these Terms.
